### Objectives and Investment Policy

The investment objective of the Company is to provide capital growth, with income being of secondary importance, net of fees, over a rolling 5 year period.

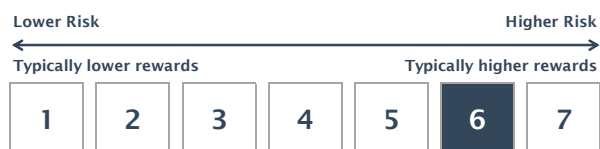
The Company will invest in a global portfolio which will typically comprise of equities (at least 80%). The Company may also invest in fixed income instruments and other transferable securities, money market instruments, cash, near cash and deposits.

The exposure to equities may fall below 80% during difficult markets. The above exposure may be gained directly or through the use of collective investment vehicles (including exchange traded vehicles and investment trusts) which may include collective investment vehicles managed by the ACD or its associates or the Investment Manager or its associates. Derivatives may be used for the purpose of hedging, although use is expected to be limited. The Investment Manager will actively manage the Company. This means the Investment Manager actively makes decisions about how to invest the Scheme Property (and which investments to buy and sell) instead of simply following a market index.

The information in this document relates to and is representative of the pounds sterling class. The base currency of the Fund is Canadian dollars.

Income arising from the Fund is distributed to the holders of income shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 6 due to the volatility of simulated data which sits in a range of between 15% and 25%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

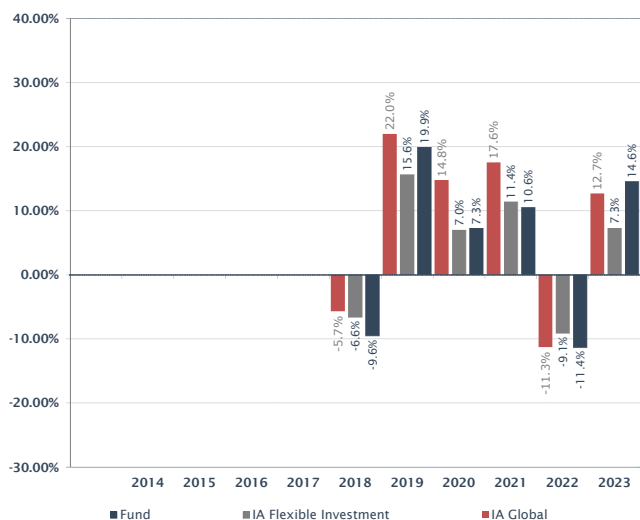
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
