#### Objectives and Investment Policy

The investment objective of the Company is to provide long-term capital growth and a consequent growth in income.

The Company seeks to achieve its objective by investing in a diversified global portfolio engaging in active asset allocation in light of market and economic conditions. The Company looks to obtain exposure to equities by investing mainly in collective investment schemes (mainly passive, including exchange traded funds, but also actively managed) as well as transferable securities. Fixed income instruments, money market instruments, cash, near cash and deposits may also be held and the company may increase its allocation to these assets when it perceives equity risk to be heightened.

The Company may enter into hedging transactions to reduce currency or other exposures, if this appears to be in the best interests of its shareholders, in light of local market conditions in the countries concerned.

Investors should note that the Company may, from time to time, invest in collective investment schemes which are managed or advised by the Investment Manager or other members of the Investment Manager Group.

The Company uses the Investment Association Flexible Investment peer group for performance comparison purposes only.

The peer group has been selected as a comparator for performance because the constituents are representative of the areas in which the Company itself is likely to invest, and it is therefore an appropriate comparator for the Company's performance.

The information in this document relates to and is representative of the pounds sterling class. The base currency of the Fund is Canadian dollars.

Income arising from the Fund is distributed to the holders of income shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

## **Risk and Reward Profile**



The risk rating of the Fund is category 5 due to the volatility of simulated data which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.
