Objectives and Investment Policy

The Fund aims to provide a total return (with a balance of income and growth of capital, both of equal importance), in pounds sterling, of inflation (as measured by CPI) plus 3% per annum, net of fees, over 5 year rolling periods.

There is no guarantee that a positive return will be achieved over this specific 5 year rolling period, or any other period and capital is at risk.

The Fund aims to achieve the Investment Objective through investment in a diversified international portfolio. The Fund will normally allocate approximately 40% - 80% to equities and 0% to 40% to bonds (either directly or indirectly through collective investment schemes and including those managed by the ACD, the Investment Managers or an associate of the ACD or Investment Managers).

The assets in which the Fund may also invest will be other transferable securities, including alternatives i.e. infrastructure and commodities (indirectly via permitted investments such as collective investment schemes), permitted closed-ended investment funds, government and public securities, warrants, money market instruments, deposits and cash or near cash investments.

The use of derivatives and/or hedging transactions is permitted in connection with the efficient portfolio management of the Fund, although its use is expected to be limited.

At times, where it is considered appropriate, for example in exceptional market conditions (such as high volatility) or pending investment, the property of the Fund will not be fully invested and prudent levels of liquidity will be maintained in order to reduce risk and preserve capital.

The Fund uses the Asset Risk Consulting Sterling Balanced Asset Index for performance comparison purposes only. This benchmark is not a target benchmark and the fund is not constrained by it.

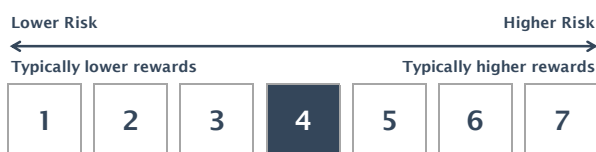
The Asset Risk Consulting Sterling Balanced Asset PCI is a risk based index that is designed to provide an accurate reflection of the actual returns an investor can expect for a given risk appetite. For the Asset Risk Consulting Sterling Balanced Asset PCI the relative risk to equity markets is 40-60%. This index has been selected as a comparator because this risk is aligned with the equity exposure as defined in the Funds Investment Policy.

The Fund also uses the CPI +3% as a target benchmark. This was chosen as a target for the Fund's return because the Fund aims to grow investments above the rate of UK inflation.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.
