Objectives and Investment Policy

The investment objective of the Company is to provide capital growth, net of fees, over a rolling 5 year period.

The Company aims to achieve the objective by actively choosing a mix of passive investment vehicles (meaning collective investment vehicles that look to replicate a given index or market). The Company will invest in a global portfolio, which will typically have exposure to at least 60% in global equities. The Company may invest in some or all sectors and in some or all world markets to take advantage of economic opportunities worldwide.

The Company may have exposure to fixed income assets (which may include government and public securities) and other transferable securities, money market instruments, cash, near cash and deposits.

The Company's exposure as between equities, fixed income and other assets, will vary over time in response to the Investment Manager's assessment of market conditions as well as the economic environment. The exposure to equities may fall below 60% under difficult market conditions in which the Investment Manager believes that markets are expensive or when higher volatility is anticipated. This could include (but is not limited to) markets resulting from, or anticipating, extreme events (for example, the 2008 global financial crisis).

Between 80% and 100% of the above exposure will be gained through the use of passive investment vehicles such as collective investment vehicles (regulated and unregulated, including exchange traded vehicles and investment trusts) which may include collective investment vehicles managed by the ACD or its associates or the Investment Manager or its associates. All other exposure will be attained from direct investments.

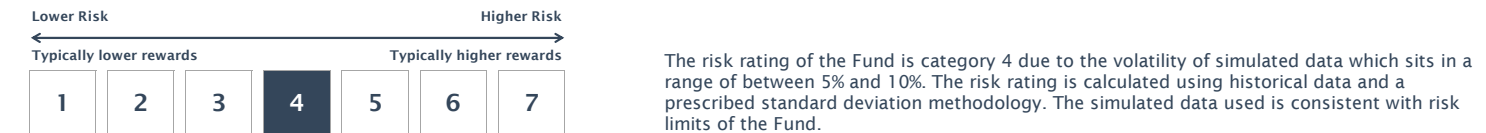
In addition, the Company may invest in eligible alternatives (e.g. gold, commodities, renewable energy and real estate) indirectly via permitted instruments such as collective investment vehicles.

Derivatives may be used for the purpose of Efficient Portfolio Management (including hedging), although use is expected to be limited. The Investment Manager will actively manage the Company. This means the Investment Manager actively makes decisions about how to invest the scheme property (and which investments to buy and sell (including which passive investment vehicles)) instead of simply following a market index.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

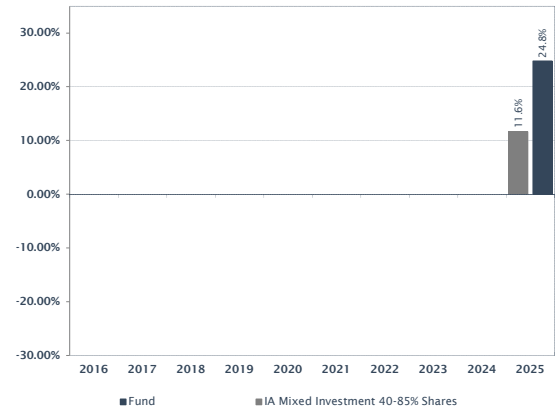
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
