Objectives and Investment Policy

The objective of the Scheme is to achieve long-term growth by closely tracking the performance of the following indices: S&P UK Broad Market Index, S&P Developed ex-UK ex-Korea Broad Market Index and MSCI Emerging Markets NTR Index.

Exposure will be achieved by investing directly into constituent companies or via other transferable securities or units in collective investment schemes giving exposure to such companies or the relevant indices. Derivatives may be used for hedging purposes and meeting the investment objectives of the Scheme. The Scheme may also invest in warrants, approved money market instruments and deposits.

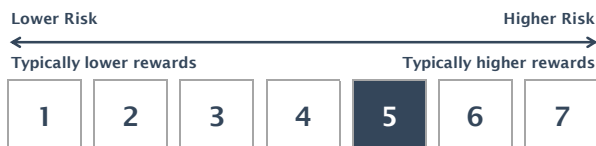
The S&P UK Broad Market Index and S&P Developed ex-UK ex-Korea Broad Market Index are third country benchmarks which may be used under transitional provisions in the Benchmark Regulation until 1 January 2020.

The Scheme targets a benchmark of the S&P as detailed in the objective. The indices have been selected as benchmarks because the constituents are representative of the areas in which the Scheme itself is likely to invest, and therefore an appropriate comparator for Scheme's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

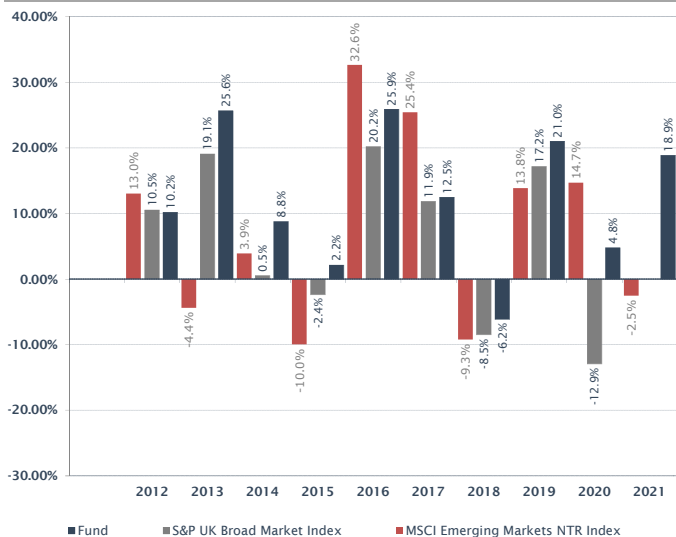
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
