

## Pollen Street agrees acquisition of Tutman

Tutman is well positioned to capture this growth and is actively progressing a number of strategic expansion initiatives in Luxembourg and Ireland, two of Europe’s most important fund domiciles. Pollen Street’s backing will enable Tutman to scale further into Europe with an existing pipeline of potential acquisitions to build a multi-jurisdiction service platform.
