Objectives and Investment Policy

The objective of the Fund is to provide a combination of capital growth and income over the medium to long term (over 5 year rolling periods) which matches the performance of the MSCI ACWI IMI Index, less fees.

The Fund will seek to gain exposure to equities (90% - 100%) by investing in a mixture of index-tracking instruments and exchange traded funds, including but not limited to funds traded on a stock exchange that track an index. The Fund will also hold cash/cash equivalents to maintain liquidity and may also have exposure to cash indirectly via other collective investment schemes (including those managed or operated by the ACD). The Fund will invest in other collective investment schemes that may use derivatives for investment purposes.

Derivatives can be used for efficient portfolio management. The Fund's investment exposure will be diversified by taking a global approach and may be adjusted according to market conditions.

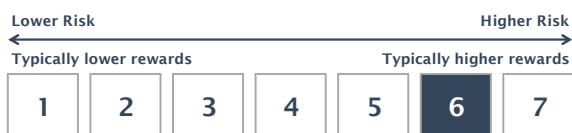
The Fund will be actively managed. This means that the Investment Manager actively makes decisions about how to invest the Scheme Property of the Fund (and which investments to buy and sell).

The performance of the Fund will be measured against the MSCI ACWI IMI Index (over 5 year rolling periods), less fees, for target return purposes. The Investment Manager has selected the MSCI ACWI IMI Index as its reference for the Fund, as the Investment Manager believes it is the most appropriately diversified index across a range of criteria including sector, geography and market capitalisation and is a fair representation of the assets in which the Fund will invest, in line with its investment objective and policy.

The information in this document relates to and is representative of the Euro class. The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 6 due to the volatility of simulated data which sits in a range of between 15% and 25%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

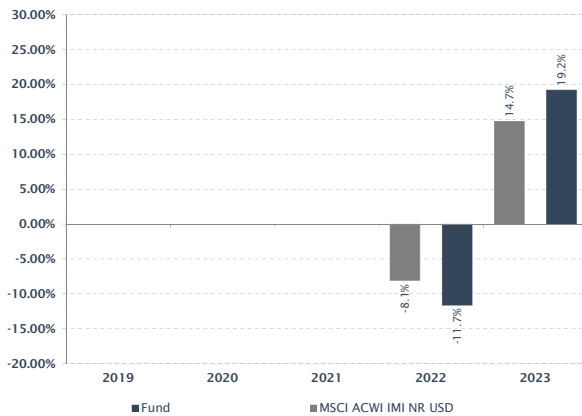
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
