### Objectives and Investment Policy

The investment objective of the Fund is to achieve long-term capital appreciation.

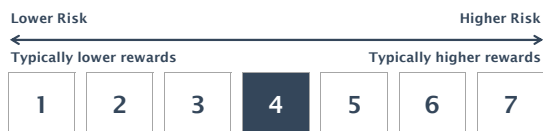
The Fund primarily invests in regulated and unregulated collective investment schemes and transferable securities in closed ended investment companies (together Investment Funds) in order to seek exposure to a diversified portfolio of asset classes, which collectively have relatively low exposure to equity market risk and volatility. The Investment Funds are managed by third party investment managers selected by the Investment Manager operating across developed and developing markets. The Investment Funds selected by the Investment Manager aim to include, but shall not be limited to, eligible fixed income funds, credit funds, absolute return funds, equity funds (both 'long-only' and hedged), private equity funds (including debt, buyout and venture) and real assets (including real estate, energy, infrastructure and commodity funds). In addition, the Fund may invest in transferable securities (including listed equities, bonds and, subject to the limits in the COLL Sourcebook, unlisted equities) offering exposure to a similar range of asset classes.

The Fund may also invest in money market instruments, cash and near cash, deposits, derivatives and forward transactions, which in the Investment Manager's opinion will either further the Fund's investment objective or with the aim of spreading investment risk and giving the holders of the units the benefit of the results of the management of the scheme property.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices on the last Business Day of each month at 10.30pm.

### Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

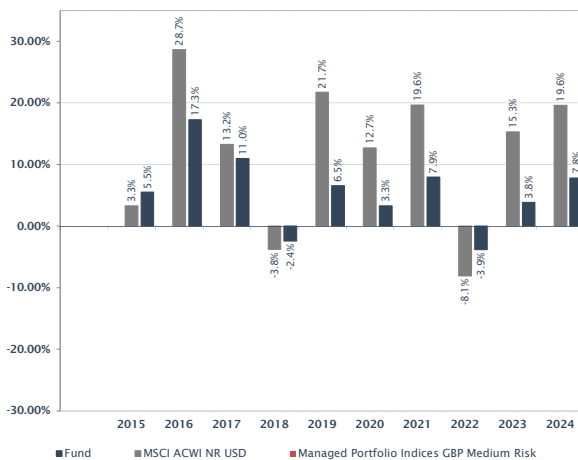
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
