Objectives and Investment Policy

The investment objective of the Fund is to achieve long-term returns of the Bank of England Base Rate +4%, net of fees, over rolling five year annualised periods. The Fund will be managed without reference to a benchmark, however, the Fund targets a lower volatility than equity markets, meaning the MSCI World Hedged. A positive return is not guaranteed and capital is in fact at risk.

The Fund seeks to achieve its objective by investing in a diversified portfolio of alternative assets, typically consisting of real estate securities, infrastructure securities, debt securities (including those issued by below-investment grade corporate bodies, developed and emerging market governments and/or supranational institutions), securitised credit instruments, convertible bonds, warrants, collective investment schemes (including index funds such as exchange traded funds (ETFs), actively managed funds, absolute return funds), cash, near cash and money market instruments. The Fund will also have the ability to invest outside of alternative assets in equity securities, equity related securities, debt securities (including those issued by corporate bodies, governments and/or supranational institutions). Indirect exposure to commodities may be sought through investment in transferable securities, eligible index derivatives and collective investment schemes.

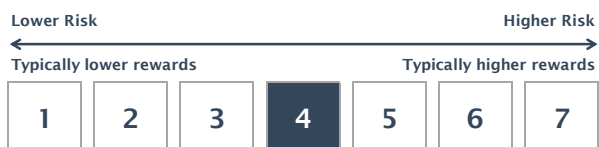
The Fund may make significant use of derivatives for investment purposes and for efficient portfolio management. The Fund will use hedging strategies to reduce risk over the short term without materially altering its risk profile.

The Fund will be managed without reference to a benchmark, however, the Fund targets a lower volatility than equity markets, meaning the MSCI World Hedged.

The information in this document relates to and is representative of the US dollar class. The base currency of the Fund is pounds sterling.

Income arising from the Fund is reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

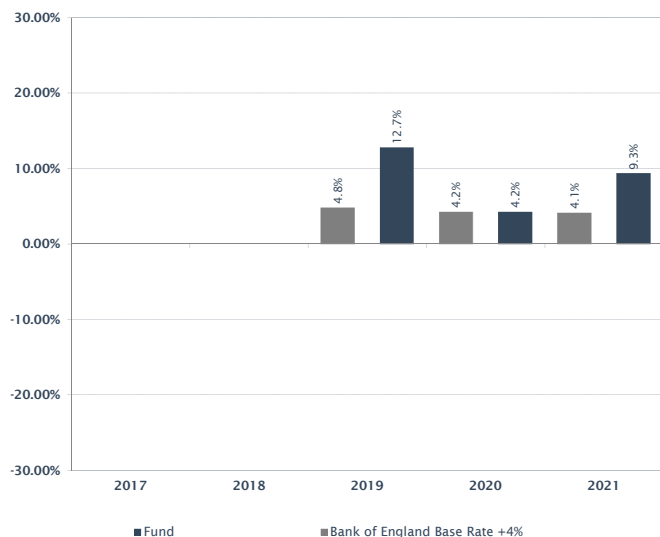
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
