Objectives and Investment Policy

The investment objective is to achieve income and capital growth through investment in the TM Gravis UK Listed Property (PAIF) Fund.

The Trust will invest all or substantially all of its assets in the Class F shares of the TM Gravis UK Listed Property (PAIF) Fund. To the extent that the Trust is not fully invested in the TM Gravis UK Listed Property (PAIF) Fund, the Trust will hold its remaining assets in cash.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can redeem shares on demand when the scheme prices daily at 13 midday.

Risk and Reward Profile



The risk rating of the Fund is category 6 due to the volatility of the Fund price which sits in a range of between 15% and 25%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

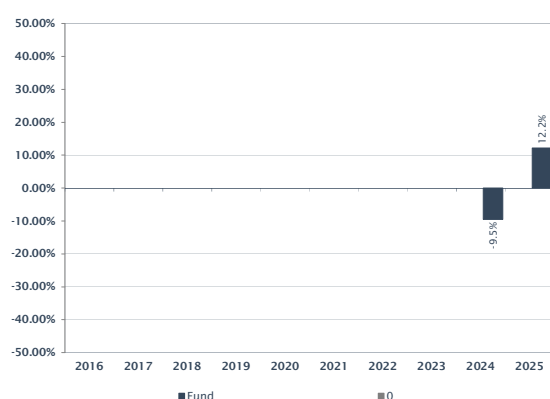
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.

The Investment Adviser of the Fund has undertaken to absorb any costs that would otherwise cause the Class G Shares of the Fund to have ongoing charges (excluding underlying collective investment undertaking holding charges) in excess of 0.65%. In absence of such commitment the ongoing charges figure would be 0.75%. It excludes:

· Portfolio transaction costs, except in the case of an entry/exit charge paid by the Fund when buying or selling units/shares in another collective investment scheme.
