
### Objectives and Investment Policy

The objective of the Company is to achieve a combination of capital growth and income, net of fees, over a rolling 5 year period. The Company will invest in a global portfolio which will typically comprise of equities (at least 60%). The remainder of the Scheme Property of the Company may be invested in fixed income assets (which may include government and public securities) and other transferable securities, cash and money market instruments. In addition, the Company may invest in eligible alternatives (e.g. infrastructure, gold and commodities) indirectly via permitted instruments such as investment trusts or other collective investment vehicles. Between 70% and 100% of the above exposure will be gained through the use of collective investment vehicles (regulated and unregulated, including those managed by the ACD or its associates or the Investment Manager or its associates), which may include investment trusts, Exchange Traded Funds and Index Funds. The allocation to collective investment vehicles will vary within the range of 70%-100% depending on markets and to take advantage of the expertise available via such collective investment vehicles. All other exposure will be attained from direct investments. In addition, the exposure to equities may fall below 60% during difficult markets. It is the ACD's intention that derivatives and forward transactions will only be used for Efficient Portfolio Management. The Investment Manager will actively manage the Company. This means the Investment Manager actively makes decisions about how to invest the Scheme Property (and which investments to buy and sell) instead of simply following a market index.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares. Investors can buy and sell shares on demand when the scheme prices every Wednesday where the last Business Day of a month does not fall during that week and the last Business Day of the month at 8.30am.

### Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.


The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
