# Objectives and Investment Policy

The objective of the Fund is to provide a long term return through capital and income, preserving the underlying value in real terms, as measured against inflation.

The Fund will utilise a range of investment classes. It will invest mainly in bonds and equities worldwide either directly or via collective investment schemes but may also invest in warrants, money market instruments, derivatives and forward transactions for the purpose of efficient portfolio management and investment purposes. Deposits in cash and Units in both regulated and unregulated collective investment schemes will be allowed. The portfolio will concentrate on major markets and liquid investments in line with a conservative lower volatility approach to the build up of value within the Fund. Under the FCA Rules the Fund may also invest in gold, however as the policy is to concentrate on liquid investments, such investment would only be undertaken with due consideration to market circumstances.

Cash and near cash will be held to enable the pursuit of the investment objectives of the Fund or, as necessary to enable redemption of Units, the efficient management of the Fund in accordance with its investment objective, and other ancillary purposes.

The investment policy of the Fund may mean that at times, where it is considered appropriate, the property of the Fund will not be fully invested and that prudent levels of liquidity will be maintained.

The Fund uses the UK Consumer Price Index (CPI) + 3% benchmark for performance comparison purposes only and the benchmark is not a target benchmark and the Fund is not constrained by it.

The index has been selected as a benchmark for performance because the constituents are representative of the areas in which the Fund itself is likely to invest, and it is therefore an appropriate comparator for the Fund's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.

### **Risk and Reward Profile**



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.


