Objectives and Investment Policy

The objective of the Fund is to achieve capital growth, net of fees, over a 5 year rolling period.

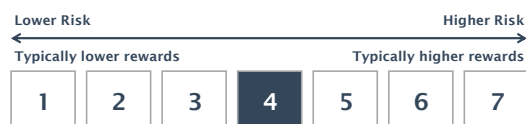
The Fund's core exposure (in excess of 80%) will be to global equities gained predominantly (80% or more) through investment in collective investment vehicles. These may be managed or operated by the Manager or the Investment Manager (or an associate of the Manager or the Investment Manager). Exposure to global equities may also be attained via direct investment.

The Fund may also invest (directly or indirectly) in bonds, government and public securities, warrants, money market instruments, deposits and cash or near cash investments. At times, where it is considered appropriate, for example in exceptional market conditions (such as high volatility) or pending investment, the property of the Fund may not be fully invested but may be held in cash or near cash. Prudent levels of liquidity will be maintained in order to reduce risk and preserve capital. The Fund may use derivatives for Efficient Portfolio Management (EPM) (including hedging). The use of derivatives is expected to be limited and is not intended to increase the risk profile of the Fund. The Fund will be actively managed, which means the Investment Manager decides which investments to buy and sell and when.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 10.30 pm.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

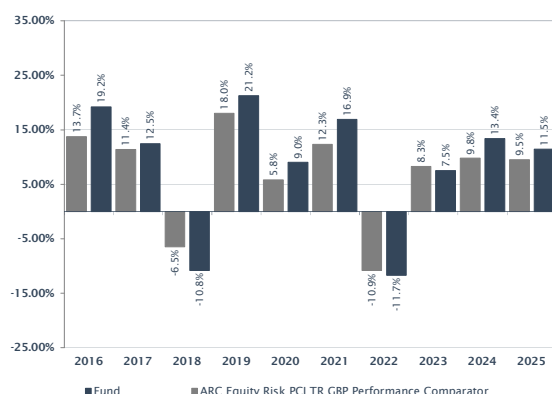
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
