Objectives and Investment Policy

The objective of the Fund is to achieve capital growth and an element of income.

To achieve the objective, the Fund's assets will be invested predominantly in UK and international regulated equity funds. There may be some use of derivatives for hedging or Efficient Portfolio Management ("EPM") purposes. In seeking to meet the investment objective, a portion of the Fund's property may be invested in units or shares of collective investment schemes managed or operated by the Investment Manager or an associate of the Investment Manager. As indicated above, the property of the Fund will be invested so as to provide a prudent spread of risk and to achieve capital growth and an element of income.

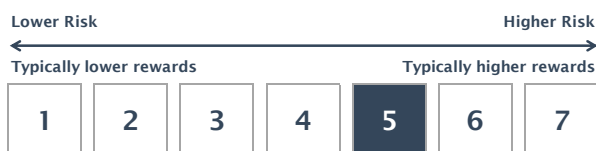
The Fund uses the Asset Risk Consulting Equity Risk Index for performance comparison purposes only and the benchmark is not a target benchmark and the fund is not constrained by it.

The index has been selected as a comparator for performance as an aggregation of a large number of Sterling based multi-asset mandates in the industry with a similar level of volatility, they offer a clear comparator.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 10.30 pm.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

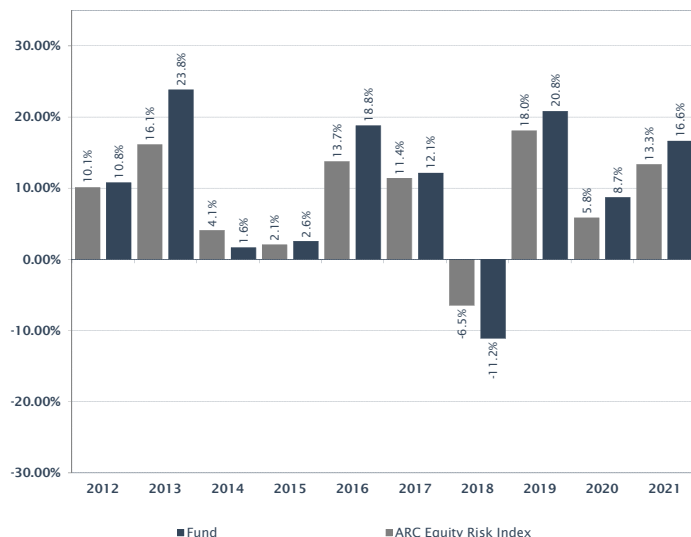
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
