#### **Objectives and Investment Policy**

To provide long term capital growth net of fees from a portfolio of investments over the longer term (5 year rolling period).

The Fund's core exposure will be to equities (80-100%), across any geographical sector.

The above exposure will be gained primarily (70% or more) through the use of collective investment vehicles (including those managed or operated by the ACD or its associate). All other exposure will be attained from direct investments.

At the Investment Manager's discretion, the Fund may also invest in other transferable securities, money market instruments, cash and near cash.

The Fund will be actively managed which means the Investment Manager decides which investments to buy and sell, and when.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.
