### Objectives and Investment Policy

To provide capital growth net of fees through a portfolio of investments over the longer term (5 year rolling period).

The Fund's exposure will be to global equities and bonds with an emphasis on global equities (60- 90%) and to a lesser extent bonds (5-35%), across any geographical sector. All bond allocations will be in sterling or sterling hedged instruments. The above exposure will be gained primarily (70% or more) through the use of collective investment vehicles (including those managed or operated by the ACD or its associate). All other exposure will be attained from direct investments. At the Investment Manager's discretion, the Fund may also invest in other transferable securities, money market instruments, cash and near cash. The Fund will be actively managed which means the Investment Manager decides which investments to buy and sell, and when.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.


The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
