Objectives and Investment Policy

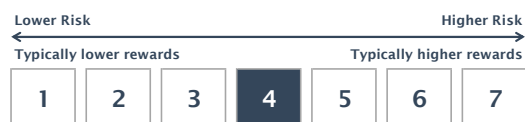
To generate income from a portfolio of investments over the longer term (5 year rolling period).

The Fund's core exposure will be to income producing equities and bonds (at least 60%) with more of an emphasis on equity income. The equity and bond allocations will each have exposure to the UK. Equity exposure will typically be between 40-70%, of which 25-55% of the Fund will be in UK equities (defined as companies incorporated, domiciled or with a significant proportion of their business in the UK) and bond exposure will typically be between 25-55%. All bond allocations will be UK bonds issued in sterling or global bonds either issued in or hedged back to sterling. The above exposure will be gained through any combination of collective investment vehicles (including those managed or operated by the ACD or its associate) and direct investments, which may fluctuate depending on the market conditions and opportunities available. At the Investment Manager's discretion, the Fund may also invest in other transferable securities, money market instruments, cash and near cash. It is not intended that the Fund invests in derivative instruments. The Fund will be actively managed which means the Investment Manager decides which investments to buy and sell, and when.

The base currency of the Fund is pounds sterling.

Income arising from the fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

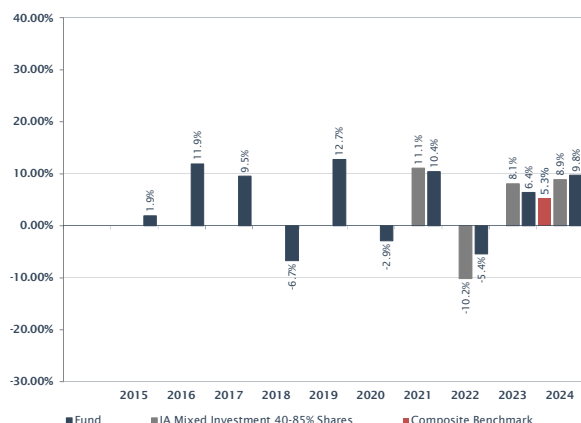
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
