### Objectives and Investment Policy

The investment objective of the Company is to achieve long term capital growth (over a rolling 5 year period, net of fees). Capital is at risk. There is no guarantee that this objective will be achieved over five year rolling periods, or any time period.

The Investment Manager will seek to achieve the objective of the Company through exposure to global equities (at least 90%), and through investment in any or all economic sectors.

At the Investment Manager's discretion, the Company may also invest in other transferable securities including money market instruments, cash, near cash and deposits.

Up to 50% of the Company's total exposure will be gained through the use of collective investment vehicles, which may include exchange traded vehicles, index funds and investment trusts (including those managed by the ACD or its associates or the Investment Manager and its associates). All other exposure will be attained from direct investments. It is expected that exposure to UK companies (defined as companies incorporated, domiciled or with a significant proportion of their business in the UK) will normally be via direct investment.

The exposure to equities may fall below 90% under difficult market conditions in which the Investment Manager believes that markets are expensive or when higher volatility is anticipated. This could include (but is not limited to) markets resulting from, or anticipating, extreme events (for example, the 2008 global financial crisis).

The use of derivatives and/or hedging transactions either directly or indirectly (through collective investment schemes) is permitted in connection with the Efficient Portfolio Management of the Company. It is not intended that the use of derivatives for this purpose will be frequent.


The investment policy of the Company may mean that at times, where it is considered appropriate, the scheme property of the Company will not be fully invested and that prudent levels of liquidity will be maintained in order to reduce risk and preserve capital.

The Investment Manager will actively manage the Company. This means the Investment Manager will actively make decisions about how to invest the scheme property (and which investments to buy and sell) instead of simply following a market index.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.
