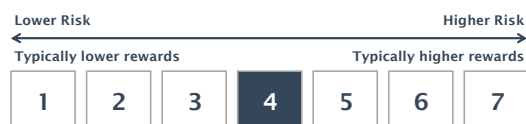
Objectives and Investment Policy

The investment objective of the Fund is to provide capital growth, with income being of secondary importance, net of fees over a rolling 5 year period. The Fund will invest in a global portfolio, in any or all economic sectors which, in normal market conditions, will comprise of at least 80% in equities. The remainder of the scheme property may be invested in fixed income assets (which may include government and public securities) and other transferable securities, money market instruments, cash, near cash and deposits. Between 60% and 100% of the above exposure will be gained through the use of collective investment vehicles (regulated and unregulated, including those managed by the Manager or its associates or the Investment Manager or its associates), which may include investment trusts, exchange traded funds and index funds. The allocation to collective investment vehicles will vary within the range of 60%-100% depending on market conditions and to take advantage of the expertise available via such collective investment vehicles. All other exposure will be attained from direct investments. In addition, the Fund may invest in alternatives (e.g. private equity, commodities, property and infrastructure) indirectly via permitted instruments such as collective investment vehicles. The exposure to equities may fall below 80% under difficult market conditions in which the Investment Manager believes that markets are expensive or when higher volatility is anticipated. This could include (but is not limited to) markets resulting from, or anticipating, extreme events (for example, the 2008 global financial crisis). Derivatives may be used for EPM (including hedging), although use is expected to be limited. The investment policy of the Fund may mean that at times, where it is considered appropriate (e.g. during difficult market conditions), the Scheme Property of the Fund will not be fully invested and that prudent levels of liquidity will be maintained in order to reduce risk and preserve capital. The Investment Manager will actively manage the Fund. This means the Investment Manager actively makes decisions about how to invest the Scheme Property (and which investments to buy and sell) instead of simply following a market index.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 10.30 pm.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

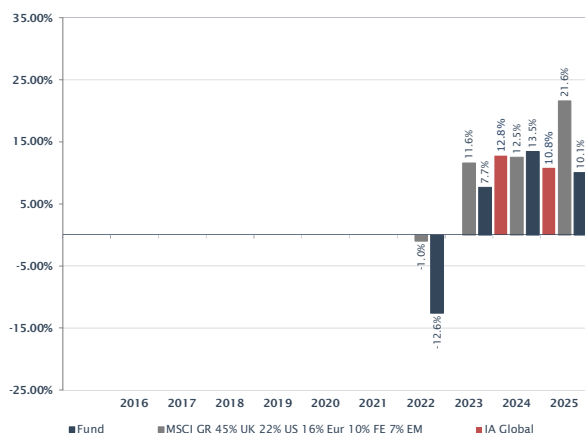
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
