Objectives and Investment Policy

The Company aims to achieve a capital and income return (net of fees) in excess of inflation, as measured by the Consumer Price Index (CPI), over the long term (over a 5 year period)

Capital is at risk. There is no guarantee that this objective will be achieved over five years, or any time period.

The Company invests in a diversified global portfolio. The Company may invest up to 65% in equity markets and 35% in fixed income assets. Such investment may be made directly or indirectly through the use of collective investment schemes. The Company may also invest, directly or indirectly (through the use of collective investment schemes), in warrants, money market instruments, deposits, cash and near cash. The Company may also achieve indirect exposure to real property through the use of collective investment vehicles.

The use of derivatives and/or hedging transactions either directly or indirectly (i.e. via collective investment schemes) is permitted in connection with the Efficient Portfolio Management of the Company. It is not intended that the use of derivatives for this purpose will be frequent.

The Consumer Price Index (CPI) has been selected as the Company's target return benchmark as the Company aims to achieve a return (the money made or lost on an investment) in excess of the rate of inflation. The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.
