#### Objectives and Investment Policy

To provide long term capital growth and maximise overall return.

The Company aims to achieve the investment objective through investment in any world markets, including the UK.

To take advantage of economic opportunities worldwide, the Company may invest directly and indirectly (through collective investment schemes) in equities, bonds, warrants, approved money market instruments, cash and deposits. Investment in gold, property and commodities may be made through collective investment schemes.

The Company appoints multiple Investment Managers to achieve its objective. Allocations to Investment Managers are subject to change in order to meet the Company's objective and further details regarding the allocations are available upon request from the ACD.

Transactions in derivatives may be used for the purposes of efficient portfolio management.

Investors may use the Investment Association Flexible Investment peer group for performance comparison purposes.

The peer group has been selected as a comparator for performance because it consists of funds similar to the Company. Many funds sold in the UK are grouped into sectors by the Investment Association (the trade body that represents UK investment managers) to help investors to compare funds with broadly similar characteristics. It is therefore an appropriate comparator for the Company's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### **Risk and Reward Profile**



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.


