Objectives and Investment Policy

The objective of the Scheme is to achieve long term (5 years plus) capital appreciation.

The Scheme will invest primarily in equities, both in developed and emerging world markets.

The Scheme will, largely, be managed to be a passive strategy and the portfolio will be constructed to predominantly replicate the MSCI ACWI Index. As such, the Scheme will be constrained by this Index. Investment may also be made in other asset classes including other types of transferable securities, units of collective investment schemes with multi-asset exposure, warrants, deposits, cash, near cash and money market instruments. Derivatives may be employed in the pursuit of the investment objectives of the Scheme for both investment purposes and for the purposes of Efficient Portfolio Management. Using derivatives and forward transactions for investment purposes may increase the volatility and the risk profile of the Scheme. The Scheme will not maintain an interest in immovable property or tangible movable property.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices at 10.30 pm.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

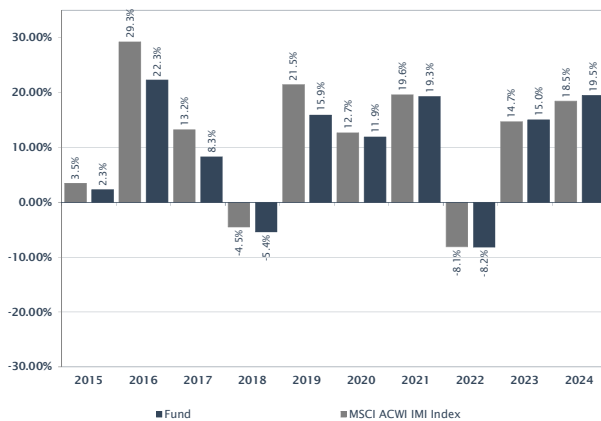
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
