### Objectives and Investment Policy

The investment objective of the Company is to provide capital growth and income over the long term through diversified investment, principally in equities and fixed interest securities.

The Company will be diversified by investment, whether directly or via collective schemes, domestically, internationally, across a range of industries and may include smaller and medium sized companies, as well as the largest "blue chips" and both sovereign and corporate debt.

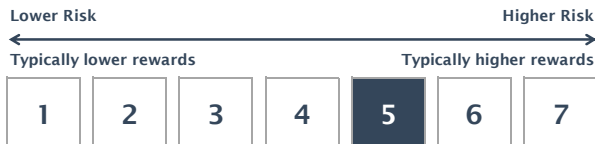
There may be occasions when the investment manager chooses to hold high levels of cash and money market instruments.

The Company's performance may be compared against the MSCI AC World Net Total Return Index GBP (referred to as 'comparator benchmark'). The comparator benchmark has been selected as we consider it assists in evaluating the Company's performance against Global equity returns. The Company is not constrained by the benchmark and may take positions that differ significantly from the benchmark.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares. Investors can buy and sell shares on demand when the scheme prices daily at 10:00am.

### Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

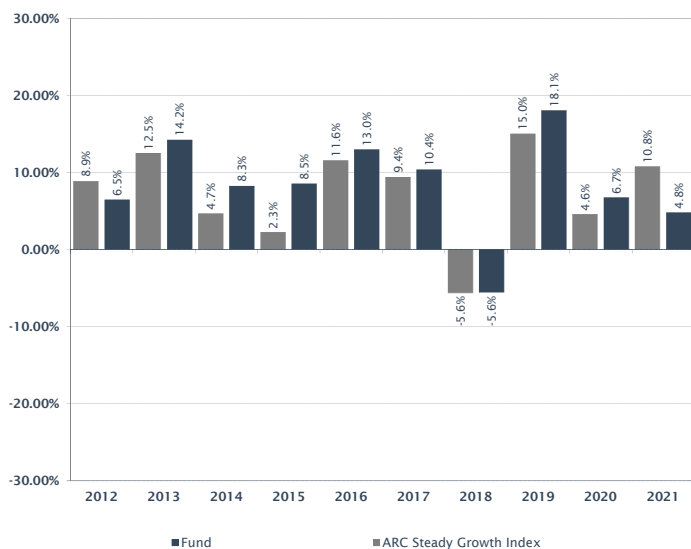
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
