Objectives and Investment Policy

The Fund seeks to deliver long-term capital growth.

At least 50% of the Fund's assets (excluding cash) will be invested in collective investment schemes, approved money market schemes, closed ended funds and exchange traded funds that invest in equities, bonds, fixed income securities and in alternative asset classes including private equity, property and commodities. The Fund may invest directly in equities, bonds, fixed income securities and money market instruments and may hold cash.

Although the Fund will generally remain fully invested, in periods of economic or market uncertainty the Manager may pursue a defensive investment strategy involving the holding of cash or near cash. In order to preserve capital during such periods holdings of cash or near cash may constitute more than 50% of the Fund's portfolio.

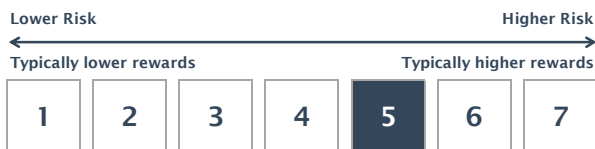
The Fund may utilise derivatives for efficient portfolio management purposes.

The Fund uses the inflation (as measured by the UK Consumer Price Index) plus 4% (net of fees) for performance comparison purposes only. The benchmark is not a target benchmark and the fund is not constrained by it.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 10.30pm.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

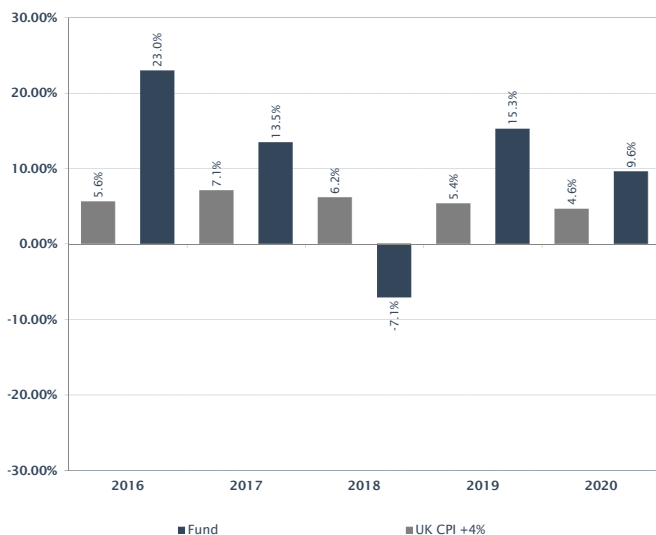
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
