Objectives and Investment Policy

The objective is to maximise the capital return through investment in both the UK and international markets. The Trust will be able to invest in transferable securities, collective investment schemes, money market instruments, cash and deposits that can best take advantage of economic opportunities worldwide.

It is the Manager's intention that derivatives be used for hedging purposes using efficient portfolio management style techniques and may also be used for investment purposes on the giving of 60 days' written notice to unitholders.

The Trust may invest in immovable property on the giving of 60 days' notice to unitholders by the Manager.

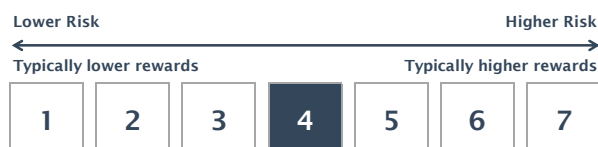
The Trust will be managed in a manner that maintains eligibility for the stocks and units component of a personal equity plan or individual savings account.

The Investment Association Flexible Investment peer group has been selected as a comparator for performance because the constituents are representative of the areas in which the Trust itself is likely to invest, and it is therefore an appropriate comparator for the Trust's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is reinvested in the case of accumulation units. Investors can buy and sell units on demand when the scheme prices each Thursday, except in the week when the last Business Day of the month falls, when the Dealing Day will be the last Business Day of the month only at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

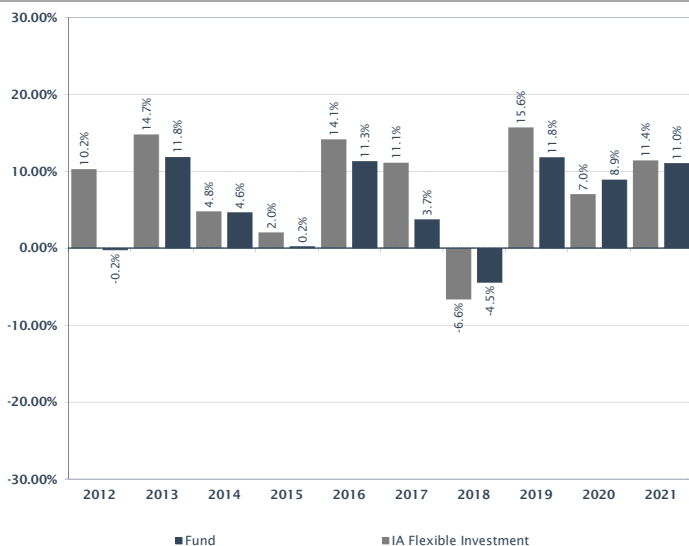
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
