Objectives and Investment Policy

The investment objective of the Company is to achieve growth in capital and income by investing in any country and in any economic sector of the world.

Growth in terms of income and capital gains will be sought by constructing a spread of investments. The Company may invest in transferable securities, money market instruments, deposits, units in collective investment schemes (both regulated and unregulated) and derivatives. Derivatives may be used for investment purposes and for Efficient Portfolio Management (including hedging). The Company will pursue a conservative investment strategy by appointing a number of Investment Managers with differentiated investment styles that have historically produced different returns in different market conditions. While the Investment Managers will have access to a broad range of asset classes, the Company may from time to time be fully invested in a particular type of investment. However, in keeping with the conservative investment strategy, it is not anticipated that extensive use will be made of warrants. The Company may, from time to time, hold a significant part of the scheme property in cash or near cash.


The Company appoints multiple Investment Managers to achieve its objective. Allocations to Investment Managers are subject to change in order to meet the Company's objective and further details regarding the allocations are available upon request from the ACD.

Investors may use the Investment Association Flexible Investment peer group for performance comparison purposes. The peer group has been selected as a comparator for performance because it consists of funds similar to the Company. Many funds sold in the UK are grouped into sectors by the Investment Association (the trade body that represents UK investment managers) to help investors to compare funds with broadly similar characteristics. It is therefore an appropriate comparator for the Company's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.


