Objectives and Investment Policy

To maximise total return in sterling terms through a combination of growth and income.

The Trust aims to achieve the Investment Objective through a diversified portfolio spread across both UK and overseas holdings primarily investing in equities and fixed income securities. Investments will be selected from a cross-section of both geographical areas and economic sectors using a "bottom-up" approach. The Trust may also invest in money market instruments, warrants, cash, deposits and units in collective investment schemes. Investments may include equity holdings in group companies of the Manager or one or more Investment Managers and collective investment schemes managed by the Manager or an Investment Manager.

The Trust may make use of efficient portfolio management techniques to reduce risk and/or costs in the Trust and to produce additional capital or income in the Trust. Techniques used by the Trust may include using derivatives (including, without limitation, total return swaps or financial derivative instruments with the same characteristics) for hedging, borrowing and holding cash.

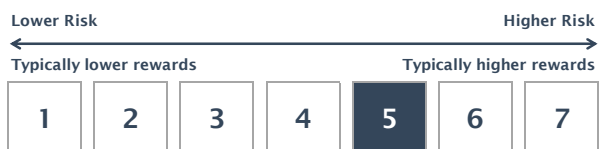
The Trust appoints one or more Investment Manager(s) to achieve its objective. Allocations to Investment Managers are subject to change in order to meet the Trust's objective and further details regarding the allocations are available upon request from the Manager.

The Trust as a whole uses the Investment Association Flexible Investment peer group for performance comparison purposes. The peer group has been selected as a comparator for performance because it consists of funds similar to the Trust. Many funds sold in the UK are grouped into sectors by the Investment Association (the trade body that represents UK investment managers) to help investors to compare funds with broadly similar characteristics. It is therefore an appropriate comparator for the Trust's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units, and reinvested in the case of accumulation units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of simulated data which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

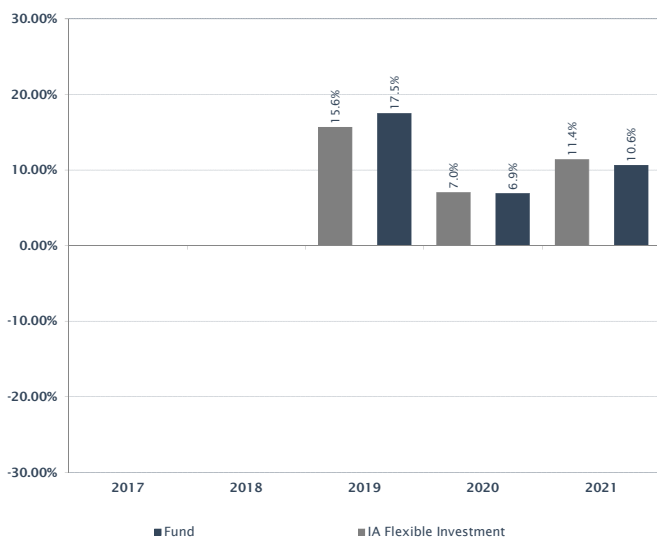
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
