Objectives and Investment Policy

We seek to grow the Fund (by increases in investment value and income) by 5% a year more than inflation. We measure performance over a rolling 5 year period after deducting fees and costs. We measure inflation using the Consumer Price Index (CPI).

We generally invest at least 65% of the Fund in the shares of companies from around the world.

We may also invest in cash or bonds or units in funds (including those managed by the ACD or its associates or any of the Investment Managers or their associates).

The allocation to shares of companies may be substantially more (up to 100%) or less than the amount referenced above depending on market conditions, in which case the allocations to cash, bonds and units in funds may also be adjusted accordingly.

We use derivatives to adjust how sensitive the Fund is to changes in currencies, to act on opportunities or control risk, to gain cost-effective access to investments, and to generate income. Derivatives are financial contracts whose value is linked to the price of another asset (e.g. indices, rates, share prices, currencies).

Benchmark information: The Fund's performance can be assessed by reference to the ARC Steady Growth Private Client Index. This represents a typical peer group for the Fund.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.


