Objectives and Investment Policy

The objective of the Fund is to achieve a mixture of income and capital growth.

Global exposure will be sought by investing predominantly in equities and fixed interest securities to be held directly (where eligible) or indirectly through collective investment schemes. The Fund can also invest in money market instruments, deposits, units in other collective investment schemes, hedge funds, venture capital, commodities, infrastructure and property, in accordance with the Fund's investment and borrowing powers in order to achieve the Fund's objective. The Fund may at times hold high levels of cash or specific investment types due to market movements, as a short term measure in times of market stress. The Investment Managers may also make use of some derivative/option facilities where considered prudent for efficient portfolio management or investment purposes.

The benchmark for the Fund is the ARC Balanced Index, which it will aim to outperform.

The index has been selected as a comparator for performance because the constituents are representative of the areas in which the Fund itself is likely to invest, and it is therefore an appropriate comparator for the Fund's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of simulated data which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.
