#### Objectives and Investment Policy

The investment objective of the Company is to achieve a long term increase in the value of capital (greater than 5 years) with income being of secondary importance. Investors should be willing and able to commit to an investment of at least five years and preferably longer. There is no guarantee that a positive return will be achieved over five years, or any other period. Your capital is at risk.

The Company will invest primarily (up to 70%) in equities (indirectly through collective investment schemes). The Company will pursue its investment objective by constructing an international spread of investments and in any economic sector of the world. The Company will also invest in transferable securities, money market instruments, deposits and units in collective investment schemes (regulated and unregulated) to attain its objectives.


The Company may gain access to these asset types either directly or indirectly and may be predominantly (up to 80%) invested in other collective investment schemes. The weighting of the investment in each asset may vary as appropriate and there may be times where there is no exposure to some asset classes. Collective investment schemes may be managed by either the ACD or the Investment Manager.

There may be occasions when the Investment Manager chooses to hold a significant proportion of the Company's assets in cash and near cash instruments. The Company will have no interest in immovable or movable property. Investment may be made in a second scheme managed by the AIFM or its Associate. Derivatives may be used for Efficient Portfolio Management in accordance with the FCA Rules.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

## **Risk and Reward Profile**



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.
