### Objectives and Investment Policy

The fund aims to achieve capital growth with the potential for some income by investing in sustainable companies that are considered by the appointed Investment Manager to rank highly on Environmental, Social and Corporate Governance (ESG) measures.

The portfolio will generally maintain a greater than 50% exposure to equities. Exposure may also be gained through fixed income securities/bonds, cash and cash instruments and other assets classes as deemed appropriate in market conditions. This exposure may be obtained either directly or through collective investment vehicles.

The Investment Manager may seek over certain periods, while particular market conditions prevail, to invest with a heavy bias towards any single asset class or type, reflecting their perspective of the investment cycle and their view of the optimal pay-off between risk and return. This may include holding substantial amounts of the fund in cash from time to time in periods when the Investment Manager considers that other asset classes may be over-valued.

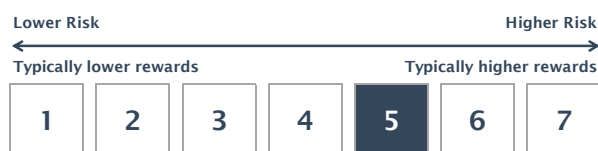
The fund may use derivatives for the purpose of efficient portfolio management.

The fund will be constrained by the exclusion of companies involved in nuclear and weapons manufacture and companies that breach the Human Rights Universal Declaration.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

### Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of simulated data which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

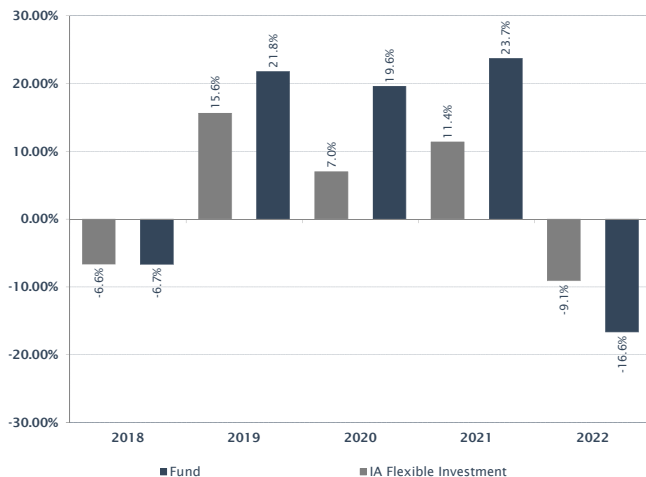
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
