### **Objectives and Investment Policy**

The investment objective of the Company is to achieve growth in capital and income through investing in any country and in any economic sector of the world.

Growth in terms of income and capital gains will be sought by constructing an international spread of investments. The Company may invest in transferable securities, money market instruments, deposits, units in collective investment schemes (both regulated and unregulated) and derivatives.

Derivatives may be used for investment purposes and for Efficient Portfolio Management (including hedging).

The Company uses the UK Consumer Price Index (CPI) + 4% over a 7 year rolling period for performance comparison purposes due to the overall return profile.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.


