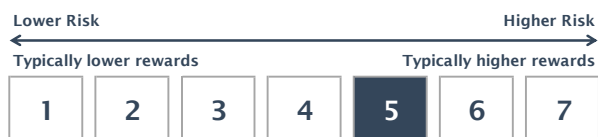
Objectives and Investment Policy

The investment objective of the Company is to achieve a combination of growth of capital and income, net of fees, over 8 year rolling periods. To achieve the objective, the Company will have exposure to a global portfolio which will typically comprise at least 70% equities (directly or indirectly through collective investment schemes). The exposure to equities may fall below 70% during difficult markets. The assets in which the Company may also invest will be other transferable securities (including warrants), money market instruments, deposits and cash or near cash investments. Between 50% and 100% of the Company's exposure will be gained through the use of regulated and unregulated collective investment vehicles (including permitted closed-ended investment funds) which may include collective investment vehicles managed by the ACD or its associates or the Investment Managers or their associates. The allocation to collective investment vehicles will vary within the range of 50-100% depending on markets and to take advantage of expertise available via funds. All other exposure will be attained from direct investments. Derivatives may be used for Efficient Portfolio Management, although use is expected to be limited. The investment policy of the Company may mean that at times, where it is considered appropriate, the Scheme Property of the Company will not be fully invested and that prudent levels of liquidity will be maintained in order to reduce risk and preserve capital. The Company will hold cash and cash equivalents to maintain liquidity. The ACD has appointed multiple Investment Managers with different investment styles to achieve the investment objective. Allocations to the Investment Managers are subject to change in order to meet the Company's investment objective and further details regarding the allocations are available upon request from the ACD. The Investment Managers will actively manage the Company. This means the Investment Managers actively make decisions about how to invest the Scheme Property (and which investments to buy and sell) instead of simply following a market index.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices twice monthly on the 15th and last calendar day of each month at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of simulated data which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

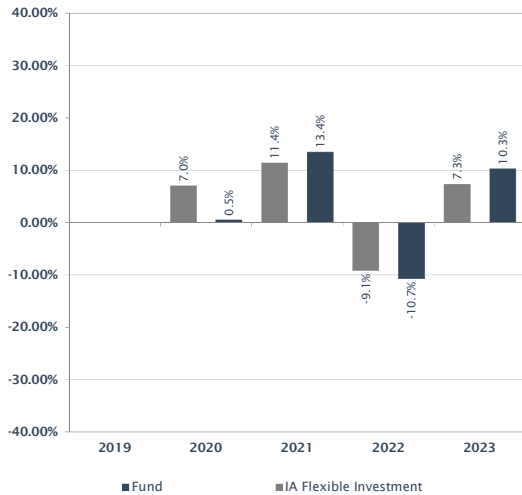
