Objectives and Investment Policy

The investment objective of the Company is to achieve long term (greater than 8 years) capital growth with income being of secondary importance.

The Company will invest primarily in equities (directly or indirectly through collective investment schemes). The Company will pursue its investment objective by constructing an international spread of investments and in any economic sector of the world.

The Company will also invest in transferable securities, money market instruments, deposits and units in collective investment schemes (regulated and unregulated) to attain its objectives. The Company may gain access to these asset types either directly or indirectly and may be predominantly invested in other collective investment schemes. The weighting of the investment in each asset may vary as appropriate and there may be times where there is no exposure to some asset classes.

There may be occasions when the Investment Managers choose to hold a significant proportion of the Company's assets in cash and near cash instruments. The Company will have no interest in immovable or movable property. Investment may be made in a second scheme managed by the AIFM or its Associate. Derivatives may be used for Efficient Portfolio Management in accordance with the FCA Rules.

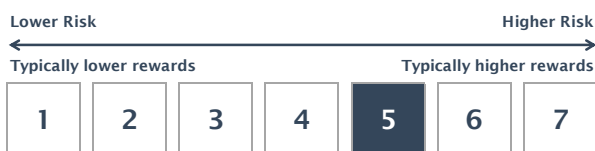
The Company uses the Investment Association Flexible Investment peer group for performance comparison purposes.

The peer group has been selected as a comparator for performance because the constituents are representative of the areas in which the Company itself is likely to invest, and it is therefore an appropriate comparator for the Company's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices twice monthly on the 15th and last calendar day of each month at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of simulated data which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology. The simulated data used is consistent with risk limits of the Fund.

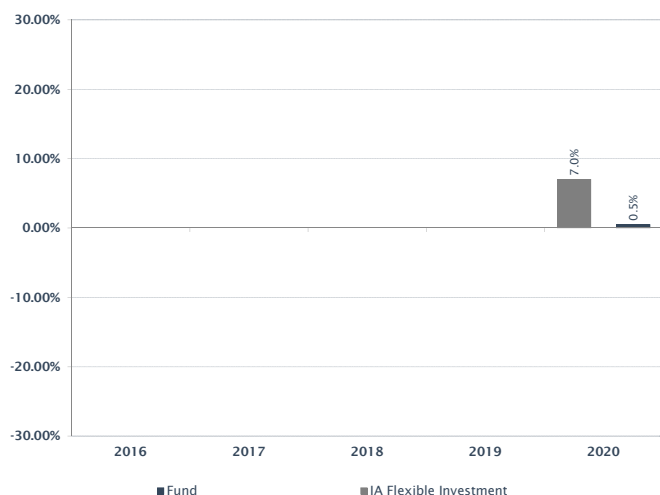
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
