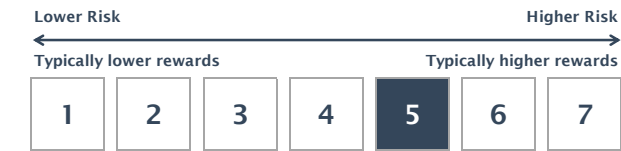
Objectives and Investment Policy

The investment objective of the Company is to provide capital and income growth, net of fees, over a rolling 5 year period. The Company will invest in a global portfolio which will typically comprise of equities (between 50-80%). The remainder of the Scheme Property may be invested in fixed income securities and other transferable securities, cash, money market instruments and derivatives. The composition of the Scheme Property as between equities, fixed income and other asset classes will vary depending on the Investment Manager's assessment of market conditions as well as the economic environment. The exposure to equities may fall below 50% during difficult markets. Between 50% and 100% of the above exposure will be gained through the use of collective investment vehicles (including those managed by the ACD or its associates or the Investment Manager or its associates), which may include investment trusts, Exchange Traded Funds and Index Funds. Typically regulated collective investment vehicles will be used but unregulated collective investment vehicles may also be used in accordance with the FCA Rules. The allocation to collective investment vehicles will vary within the range of 50%-100% depending on markets and to take advantage of the expertise available via such collective investment vehicles. All other exposure will be attained from direct investments. In addition, the Company may invest in eligible alternatives (e.g. gold and commodities) indirectly via permitted instruments, such as collective investment vehicles. Derivatives may be used for the purpose of hedging, although use is expected to be limited. The Investment Manager will actively manage the Company. This means the Investment Manager actively makes decisions about how to invest the Scheme Property (and which investments to buy and sell) instead of simply following a market index.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income shares, and reinvested in the case of accumulation shares. Investors can buy and sell shares on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 5 due to the volatility of the Fund price which sits in a range of between 10% and 15%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

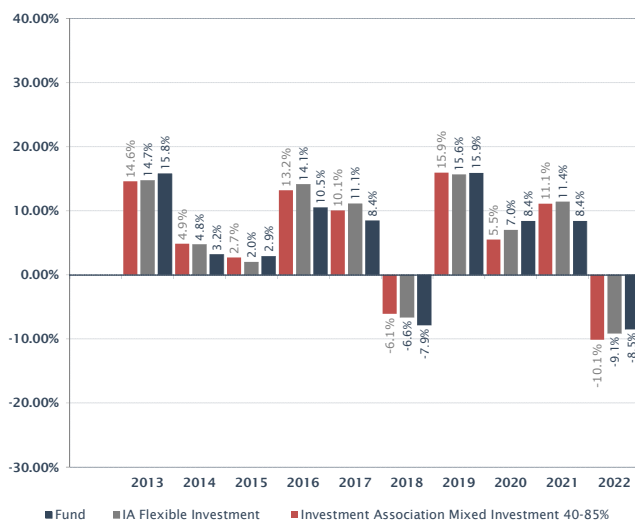
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
