Objectives and Investment Policy

The primary investment objective is to achieve positive returns, and to deliver a better return than RPI with a lower risk profile than equity investment (measured by the FTSE All Share Index) over a five year period.

Investors should be aware that the investors' capital is in fact at risk and there is no guarantee that positive returns or these rates of returns will be achieved, whether over rolling five year periods, or any time period.

The assets in which the Fund may invest will be transferable securities, units in collective investment schemes, money market instruments, deposits and cash or near cash investments. Derivatives will be used only for efficient portfolio management (including hedging).

A positive return will be sought by investing in a diversified portfolio of different asset classes.

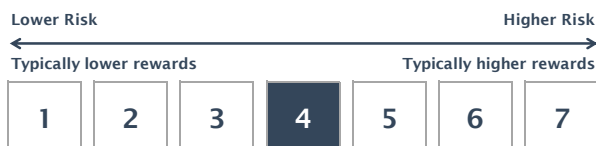
The Fund appoints multiple Investment Managers to achieve its objective. Allocations to Investment Managers are subject to change in order to meet the Fund's objective and further details regarding the allocations are available upon request from the Manager.

The Fund's performance is measured against RPI (the "Index"). The Index has been selected as a performance target because it is a key measure of consumer inflation in the United Kingdom. The Fund aims to deliver positive returns in excess of the Index. The Index is therefore an appropriate target for the Fund.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units, and reinvested in the case of accumulation units. Investors can buy and sell units on demand when the scheme prices daily at 12 midday.

Risk and Reward Profile



The risk rating of the Fund is category 4 due to the volatility of the Fund price which sits in a range of between 5% and 10%. The risk rating is calculated using historical data and a prescribed standard deviation methodology.

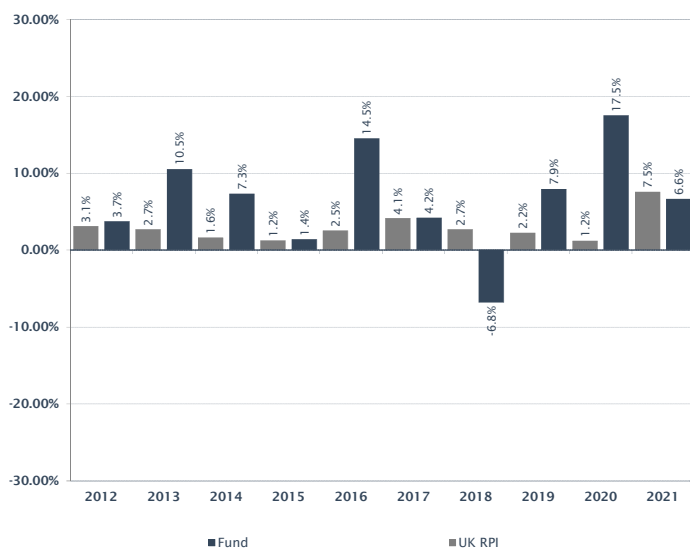
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
