Objectives and Investment Policy

The main investment objective of the Trust is to produce capital growth. This overall objective shall be pursued through diversified investment in other collective investment schemes, transferable securities, money market instruments, cash and near cash, deposits, derivatives and forward transactions, immovable property, gold and other investments to the extent that each is permitted by the Regulations.

The Trust may at times hold high levels of cash or investments other than units in collective investment schemes due to changes in market conditions or at the Investment Managers' discretion.

The Trust may invest in property for investment purposes.

The Trust appoints multiple Investment Managers to achieve its objective. Allocations to Investment Managers are subject to change in order to meet the Trust's objective and further details regarding the allocations are available upon request from the Manager.

The Trust uses the Investment Association Flexible Investment peer group for performance comparison purposes. The peer group has been selected as a comparator for performance because it consists of funds similar to the Trust. Many funds sold in the UK are grouped into sectors by the Investment Association (the trade body that represents UK investment managers) to help investors to compare funds with broadly similar characteristics. It is therefore an appropriate comparator for the Trust's performance.

The base currency of the Fund is pounds sterling.

Income arising from the Fund is distributed to the holders of income units, and reinvested in the case of accumulation units. Investors can buy and sell units on demand when the scheme prices daily at 8.30am.


